The CST Excellence Award seeks to characterize validated best management practices, as a basis for accelerating the rate of Implementation of CST programme improvement. The CST Excellence Award Scheme has been instituted by the Government of India, Ministry of New & Renewable Energy in 2016 to encourage and promote CST sector, in both manufacturing as well as service organizations in India including:

- * Government and Semi-Government departments
- * Public and private undertakings (Beneficiary, manufacturers/ suppliers, entrepreneurs)
- * All sectors of industry, service and commerce
- * Trade and professional associations
- * Educational, Healthcare, Hospitality and Research Establishments

The CST Excellence Awards will be presented to organizations in different industrial, institutional and business sectors, adjudged to have made the most significant achievement, in the CST sector.

The CST Excellence Award stimulates and helps organizations to rapidly accelerate the pace of their improvement process. The preparation for the award helps to inspire and align the entire work force, management functions and sanitized to CST potential sector and users. The knowledge gained by the organization in describing and self-assessing its operations, lead to IMPROVED organizational performance.

The Awards

Each category of Award, at the discretion of the Jury may have none or more than one award. Each winner receives a trophy together with a certificate. Selected organizations may be awarded a commendation certificate by the Jury.

A special awards committee has been constituted by the Ministry of New and Renewable Energy (MNRE), Government of India to the select the award winners.

Eligible Organizations

- 1. Public Sector Units (PSUs) separately for Manufacturing, Service.
- 2. Private Sector organizations separately for Manufacturing, Service.
- 3. Government/State Government (SNA) Local bodies, Undertakings & Public Utility Services.

The awards are divided into the different categories, based on the annual/cumulative,

Eligibility Criteria

Manufacturing or Service organizations or divisions of organizations in the private and public sectors, and government organizations may participate in the **'CST Excellence Award**.
